1 WHAT ARE COOKIES?

Cookies are small text files or fragments of information that are downloaded onto your computer, smartphone, or any other device with internet access when you visit our application.

They contain information about the way you browse through our pages and retain information related to your preferences.

Therefore, this page can store and recover data about your browsing habits, in order to improve the user experience, for example. It is important to highlight that they do not contain specific personal information, such as sensitive data or banking information.

Your browser stores cookies in the hard drive, but they occupy minimal memory space, which does not affect your computer performance. Most information is erased as soon as the session is ended, as you will see in the following topic.

2 TYPES OF COOKIES

The cookies' ownership can be:

1. First-party cookies: these cookies are defined by us or by third parties in our name.
2. Third-party cookies: these cookies are defined by trustworthy third parties in our applications.

The cookies' lifecycle can be:

1. Session or temporary cookies: these are cookies that expire as soon as you close your browser, ending the session.
2. Persistent or permanent cookies: these are cookies that are kept on your device for a certain period or until you delete them.

The cookies' purpose can be:

1. Necessary cookies: these are essential cookies that enable the navigation through our applications and the access to all resources; without these, our services may underperform or not work.
2. Performance cookies: these are cookies that optimize the way our applications work, collecting anonymous information about the pages accessed.
3. Functionality cookies: these are cookies that memorize your preferences and choices (such as username).
4. Marketing cookies: these are cookies that direct the adds due to your interests and that limit the number of times the add is shown.

3 WHY DO WE USE COOKIES?

Timpel uses cookies to provide a better user experience, making our applications easier to use and personalized, based on your choices and browsing behavior.

Therefore, we seek to understand how you use our applications in order to adjust the content to make it more relevant to you, in addition to remembering your preferences.

Cookies involved in this process inasmuch as store, read, and execute all data needed to fulfil our purpose.
